# MUSEUM OF THE MOVING IMAGE APPOINTS REGINA HARSANYI AS ASSOCIATE CURATOR OF MEDIA ARTS



Astoria, New York, January 10, 2023 — Museum of the Moving Image today announces the appointment of Regina Harsanyi as Associate Curator of Media Arts. Harsanyi joins the full-time curatorial team after serving as a consultant for the Museum's digital preservation efforts since 2020. In this new, expanded role, Harsanyi will develop and implement exhibitions, public programs, and publications dedicated to historic and contemporary works of media art, building on the Museum's 30-year history of presenting artists utilizing emerging technologies, and help to grow the Museum's collection of media art.

"Regina has been with the Museum for quite some time as a consultant, building our capacity for collecting and preserving variable media works," shares Barbara Miller, Deputy Director for Curatorial Affairs at Museum of the Moving Image. "In her role as Associate Curator of Media Arts she will be a terrific asset as we build on our previous efforts of exhibiting media art and chart new territory."

Carl Goodman, Executive Director of Museum of the Moving Image, shares, "Regina is an expert in her field and an invaluable asset to the Museum. We are thrilled to work with her on expanding the Museum's offerings in the area of Media Arts."

A graduate of New York University's Institute of Fine Arts, Harsanyi has dedicated her career to improving and promoting best practices for the longevity of variable media, from plastics to distributed ledger technologies, while creating interdisciplinary bridges between academia, museums, collectors, corporations, and artists. She has

lectured globally and led major time-based media conservation projects for multiple institutions, studios, and collectors, including the Museum of the Moving Image, bitforms gallery, and Sotheby's.

From 2017 to 2020, Harsanyi facilitated over 200 exhibitions across 26 locations under Wallplay, highlighting creative technology in the arts. Additionally, Harsanyi is a New Museum NEW INC mentor, Eyebeam advisor, and a respected scholar of blockchain technology.

This position is made possible in part by a Regrowth and Capacity grant from the New York State Council on the Arts. Additional support provided by the Mellon Foundation.

As the first museum to appoint a dedicated curator of digital media, MoMI has a history of showing innovative moving-image media arts, including work by Shigeko Kubota, Nam June Paik, and Jim Campbell. Since 1992, the Museum has mounted ongoing exhibitions devoted to digitally based art, including <Alt> Digital Media (2002); Interactions/Art and Technology (2004); JODI: Street Digital (2012); and Real Virtuality (2011), featuring work by Cao Fei, Marco Brambilla, and others exploring the boundaries between physical and digital space. Many emerging artists' first works, such as those by Corey Arcangel and Casey Reas, were presented as part of these exhibitions. Expanding from video games and digital art, MoMI has presented a series of exhibitions exploring moving images on the internet, including How Cats Took Over the Internet (2016) and The New Genres: Video in the Internet Age (2018). Recent installations have included The Situation Room (2019–2022) and The GIF Elevator (2017–2019), both Museum commissions of animated GIFs, supported by Giphy Arts; We Tripped El Hadji Diouf: The Story of a Photoshop Thread (first presented in 2012); and The Reaction GIF: Moving Image as Gesture (2016). The Museum has commissioned work by artists Nam June Paik, Martha Colburn, Sabrina Ratté, Evan Roth, RAFiA Santana, Pablo Valbuena, Ming Wong, Ezra Wube, and many others.
